

## **University of Michigan Social Venture Fund Winter 2015 Loveland Capacity Building Project**

### **I. Project Summary**

The University of Michigan's Social Venture Fund (SVF) at the Stephen M. Ross School of Business has partnered with the State of Michigan Enterprise Information Management Program and Michigan-based Loveland Technologies to explore county-wide data management practices in regard to parcel-level land data and geographic information systems (GIS) data acquisition structures.

For this project, students from SVF and the University of Michigan's Taubman College of Architecture & Urban Planning surveyed all Michigan counties to understand the cost, availability, and maintenance responsibilities of parcel and assessment data.

The SVF team, with the support of the Enterprise Information Management Program, disseminated an initial online survey consisting of 51 questions to assess each county's parcel data format and processing, public availability of data, cost structures of available data, labor associated with maintenance of data, and perception of open data initiatives across the state of Michigan. SVF and/or the Enterprise Information Management Program contacted each county, requesting that the department responsible for parcel data in their county take the online survey. SVF then followed up with each county that did not complete the initial survey with a short survey including questions deemed most relevant for this analysis.

By surveying all of Michigan's counties, SVF and Loveland compiled a statewide picture of county land data management practices. This research provides insight for potential business models that may reduce costs to counties, increase data availability and accuracy, and identify market inconsistencies.

The analysis below summarizes the 132 responses to the Michigan Parcel Data Surveys. The figures below account for only those answers that were deemed complete. All other incomplete or blank responses have been removed for this analysis.

### II. Report Data

Our report is accompanied by the following supplemental information:

#### Raw Data

Raw survey data for 101 long survey responses and 32 short survey responses may be available upon request to Loveland Technologies.



### Google Sheet (Excel Sheet)

Survey responses have been exported into a Google Sheet shared with Loveland Technologies. Extra responses from secondary county representatives and non-county responses are separated into separate sheets within this documented. Responses from both the original and abbreviated survey responses are included in the main data sheet.

#### **III. Key Takeaways**

#### Enhanced Data Access to Public Records Act

The Enhanced Access to Public Records Act allows a public body to provide access to public records and charge a reasonable fee for providing and maintaining that access. The Act defines a reasonable fee as "a charge calculated to enable recovery time of those operating expenses directly related to the Public Body's provision of Enhanced Access," but leaves room for variability and judgment in the pricing criterion used to set rates. Counties use this act to justify the prices they charge for access to parcel and assessment data. They must adopt a policy that complies with the Act before providing enhanced access under the Act.

Some survey responses suggest that this Act (and the correlated county policy) actually limits GIS officials' ability to increase access to information. For example, when asked if the public can access Complete Parcel Data in his county, one respondent wrote that their viewer meets 99% of requests, but that he is technically "caught up in the Enhanced access to GIS data law." When asked if they had an open data policy, two counties responded that they had an Enhanced Access Policy, suggesting confusion differentiating between the initiatives. Finally, when asked if their county was working on an open data policy, one respondent writes, "No, first the enhanced access policy and laws need to be revoked and education of decision makers is required to change."

### Current sales and pricing information

There is a high degree of variance in sales and pricing for parcel and assessment data across the state in terms of price methods, total number of sales, and cost specifically incurred to maintain the information. In general, the counties perform few sales and generate minimal revenue from them.

Counties employ a variety of pricing methods to sell their data. The most common sales methods for parcel and assessment data are per parcel and on a county-wide basis. Some counties have a county-wide price that is cheaper on a per parcel basis than buying each individual parcels. A few counties offer parcel and assessment per municipality. One county earns revenue off of paper map sales.

Regardless of the pricing method used, counties perform few data sales. Discounting one outlier county (Jackson), the average sales per county reporting information last year was around \$6,000. When pairing these sales with the costs incurred by employing FTEs in the sales and maintenance of parcel and assessment data, just 1-2 counties earn more money on data sales than the cost of a full-time equivalency. If counties justify the value of sales based upon the revenue the revenue they bring in, the survey data shows little evidence that counties earn profits to cover the cost of maintaining and selling data.

#### Open Data Initiative

Very few Michigan counties indicate that they have or are pursuing an open data initiative. Survey responses suggest that the counties who indicated having or pursuing an initiative vary in their interpretation of what open data entails. For example, when asked if the county is involved in conversations to participate in the statewide open data policy, one respondent writes, "Yes/No, we participate in Enhanced 911 and State Tax Commission field staff". Further research is required to understand how this concept is interpreted and practiced across counties throughout the State of Michigan.





## Overall County Response to Parcel Survey















## 14. Is Assessment Data maintained by separate cities/townships or one county/regional authority? (Select all that apply)






## 17. If Cities and Townships Maintain Assessment Data, How Often Does County Recieve Updated Assessment Data?





18. Can County Attach Assesment Data to Parcel Shape Objects?












## Q23 How can the public access Parcel Shape Objects? (Select all that apply)

### Q24 In what data formats are your Parcel Shape Objects available to the public? (Select all that apply)









GIS Shapefiles are available for all parcels, either by county, township/city/village, or section. If someone wants to just acquire assessment data without the shapefile (just an excel spreadsheet); that can be purchase for \$100 for the entire county or \$25 per township. If a county-wide parcel shapefile is purchased in one year the buyer may get an annual update for \$300 in the next consecutive years. If any years are skipped the buyer must then purchase at the full price again.

### 35. What is the Cost of County-Wide Assessment Data?






38. On Average, How Many Sales are Made Per Year of Complete Parcel Data?




39. On Average, How Many Sales are Made Per Year of Parcel Shape Objects.




40. On Average, How Many Sales are Made Per Year of Assessment Data Only?




### 41. What was the Total Revenue from Data Sales in 2014?




# 42. On Average, How Many Annual Data Updates Does the County Sell?



### 43. When Was the Current Data Pricing Model Enacted?






# 47. Does a Vendor Collect and/or Maintain Parcel Shape Objects?
